#### 5.1b MD's Report

- The WIN 2020 Car Lottery has sold out. Staff has learned a lot about digital marketing and the process of on-line ticket sales for a large event
- The spring direct mail focused on showing support for our frontline workers and has been very successful. Local companies also raised \$23,000 for a new Transport Ventilator
- Mississippi Valley Textile Museum and Ryan Gordon Photography are partnering to create a fundraising event with all proceeds coming to the Foundation
- Ms. Beckinsale is organizing a Virtual Gala for August 29, 2020. The Gala is an event that will work with Partners in the community to raise funds to cover the loss of revenue due to the need to cancel or postpone 3 out of 4 of the Foundation's Signature events
