#### 2.0 Chair Remarks

- The Chair thanked the Foundation staff for their efforts in controlling costs and taking on more items that had been previously outsourced to other companies
- The Chair thanked Mrs. Trider on behalf of the Foundation and the community for her leadership throughout the pandemic

#### 4.0 Business Items

#### 4.1 CEO's Report

- The Report of the CEO and the Senior Team September 28, 2020 was included in the meeting package.
- The Hospital continues to wait for news from the LHIN about the approval of the CT Scan application
- The experience in the community relating to Covid has been very different than the surrounding communities. Those living in Almonte and area have been very diligent.
- The Hospital is finding balance between safety of Covid and other aspects of health needs
- Jason Hann has been hired as the new Integrated VP, Patient & Resident Services and Chief Nursing Executive and is looking forward to meeting the Foundation Board

#### 4.2 MD's Report and Dashboard

- The Dashboard report is current to the end of August 2020 and was included in the meeting package
- The Virtual Run was very successful in terms of money raised
- The Radiothon brought in \$7,700 and raised awareness of the Hospital in the listening area of Lake 88.1
- Discussions have begun on the WIN 2021 event
- The Legion and the Foundation will be working together on a Chase the Ace Fundraiser. The Legion will be the lead with the Foundation being the other beneficiary. The Legion is waiting on the approval of their license.
- Canada Bank Note and the marketing company 20 Eight have already been contracted
- The fundraiser is set to begin in 2 to 3 weeks
- Mrs. Trider will announce the launch of the Chase the Ace to staff at the CEO Forum on November 10. An announcement will also be made to the Hospital Board
- A launch to announce the lottery to the public will be planned with a video of the first ticket being bought virtually
- The Foundation received a grant for \$44,000 which was not included in the Dashboard to replace all the furniture in the waiting rooms and wheelchairs due to infection control

#### 5.0 Strategic Items – DI Campaign Update

#### 5.1 DI Campaign Update

- Mr. Scott and Mr. Roberts met with Paul and Rhonda Virgin, co-chairs of the Campaign
- The Campaign needs to expand with a focus on bringing the next generation of Almonte philanthropist on board
- A cabinet will be built around the Campaign bringing new leadership and connectivity
- Mr. and Mrs. Virgin will work with the cabinet and a potential new leader as mentors
- Members will receive training in approaching potential prospects to learn how to identify new prospects
- Once the application for the CT Scan is final, the cabinet will be ready and an announcement will be made public revitalizing the campaign

#### 5.2 Strategic Plan Update

- A monitoring tool has been developed to show the process of the strategic plan
- This tool will be populated, updated and presented at each board meeting
- It was developed to give more emphasis at Board meeting on the progress of the Strategic Plan
- The completed tool was reviewed at the meeting
- The Strategic plan is progressing well
- Areas of prospect identification are harder to complete with the restrictions of Covid
- The Foundation will look for opportunities to participate in virtual meetings with other organizations to educate them on the importance of supporting the Hospital
- With respect to the item of the strategic plan engaging Hospital staff, they have been busy
  setting up procedures and best practices for dealing with Covid. Now that those practices are set
  up staff members will be will be asked to assist with thank you phone calls to donors. Staff will
  also be asked to record a video reading words of support from donors that will be received in
  connection with the fall mailing

#### 6.0a Bert McIntyre Memorial Award

- The Bert McIntyre Memorial Award was developed to annually recognize an outstanding volunteer of the Almonte General Hospital Fairview Manor Foundation

- Expenses continue to be lower with the decrease in expenses for events and a reduction in salary expenses
- The Foundation is on track to meet basic expenses and the capital commitment to the hospital but needs to get back to the growth path before Covid.
